



equipment manager reports the CDS has thirteen Aseptico ADU-04 dental units, ten Aseptico Air Pac II 110Volt compressors, two Aseptico Air Pac II 220 Volt compressors, three Aseptico AA74 220 Volt compressors, and fifteen Cheatwood-designed dental chairs. In 2013, CDS and Dave supported twenty-four trips, and so far, in 2014, there have already been twenty-six trips. The board discussed the need for more self-contained dental operating units.

Accounts will be charged when an individual uses this method for tax write-offs for mission trips. If several trips are done by the same individual, they will only pay once per year.
